

CALIBRATED ULTRAVIOLET AND ELECTROMAGNETIC ENERGY WITH USE OF CALIBRATED LIGHT

Ultraviolet Light is a form of electromagnetic energy that moves in measurable waves. Ultraviolet energy radiates between 4 nanometers (Nm) to 400 Nm wavelengths. The effectiveness of the UBI therapeutic treatment can be, in part, explained by examining the effect of ultraviolet light on the chemical structure of bacteria. First, bacterial cells are much smaller than body cell, therefore are more susceptible to irradiation. Second, certain bacteria contain significant amounts of two photosensitive amino acids, phenylalanine and tyrosine which are largely absent in the body cells.

The photo-activity of these amino acids causes the bacteria to absorb greater amounts of ultraviolet energy which in turn begins a coagulation process which destroys the bacteria. The body cells which contain approximately 20 percent of the level of these amino acids are largely unaffected. Blood irradiation may destroy some of the body cells but the stimulation of the immune system helps create new healthy blood cells to replace the lost cells. There is also some evidence that the injured cells are the key to the stimulated immune response. There is also some evidence that by destroying the bacteria in the treated portion of the blood a self-generating vaccine is produced. When the blood is returned to the patient after irradiation, the vaccine working together with the radiation given off by the treated blood (i.e. induced second-irradiation) rapidly destroys the bacteria in the blood stream.

There is also preliminary evidence that indicates the UV light in the appropriate electromagnetic field intensity attacks the DNA and RNA of viruses by binding the strands of RNA and DNA thus preventing the virus from reproduction; by re-injecting these altered viruses back into the body the body's immune system then attacks these and the non-altered virus thereby creating a vaccine effect against the disease caused by the virus.

Another important effect of blood irradiation is the increase in oxygen absorption by the blood following ultraviolet exposure Clinical studies showed an extraordinary effect on cyanotic (turning blue) patients with a result of near complete recovery of this debilitating condition, A subsequent benefit to total homeostasis is by restoring oxygen the body desperately needs to function properly the treatment induces a healthier state

This induced specific electromagnetic pattern carried electromagnetic signals for a length of time has shown electromagnetic reversal of cellular death and disease condition by irradiating the disease process is a specific healing process for that disease in the body.

In this state the body's DNA/helix has a memory of a previously healthy state and will return to that. This is what slows down aging i.e. a complete reversal of clogged arteries with fatty deposits and to lower the cholesterol level to normal good and bad. Restore order. Every biological system uses it to heal itself. Not only can we amplify and time-reverse the energy in a calibrated EM field but we can now also amplify (shorten the time required to change) and time-reverse the energy comprising a living mass.

We can gradually reverse the damaged cell back to an earlier physical condition, before the damage or disease was there! The cell itself gradually physically changes. This is the basic mechanism, uncovered by research that every living biological system uses to heal itself.

The body ages only because gradually the cellular regenerative system deteriorates a bit, so it can no longer fully restore the cells back to youthful vigor. The aging process itself can also be reversed and "cured" by precisely the same process. We emphasize that all the treatment does is accelerate and enhance the human, electrodynamics used by the body's healing process has not even been applied (And seldom even studied by Western medical scientists.)

Yet our scientific community remains hostile to the very notion of light EM healing, even though the natural healing mechanism used in all biological systems is purely electrodynamics—albeit a most unusual form of electrodynamics that the medical scientists do not study In the new method, the exact spectrum of light EM radiation FROM a diseased or cellularly-damaged body is captured and amplified, and then fed back into the body. In short, the "porthole" effect uses only ordinary EM radiation, but very precisely and very carefully measured and tailored. Yet it will also engender the same time-domain pumping back in all the deep interaction of the body, in every cell and every part of it. In short, we get a direct and very quick time-reversal of all those physical processes. Indeed, the exchange between the pathogen and the host's immune system, where the pathogen finally succeeded in tricking or avoiding the immune system as in "AIDS is also reversed back out of there and the immune system is also restored to full vigor. The result is that the immune system now recognizes the pathogens and again completely goes after them vigorously. In short, the body is again able to use its full healing power against the resistant organism again completely negating the "deception" that was achieved by the pathogen.

By using this healing power, the basic mechanism of every living biological system is used to heal itself and slow the deterioration of cells. This slows the aging process and even reversed.

The importance of the PL 2020 blood irradiation is the increase of oxygen absorption by the blood. This facilitates the body's needs to combat the major cause of aging "oxidative stress".
